I agree to indemnify, defend, and hold all of the Released Parties harmless from any and all claims, causes of action, rights to recover, and demands made against any of the Released Parties, and any cost, expense, loss, liability, or damages, incurred by any of the Released Parties arising from or in any way related to the Minor's attendance at the Event or any act or omission of the Minor during the Minor's presence in San Jose, California in connection with the Event.

6. Attached is a genuine copy of my driver's license or other acceptable form of government-issued identification bearing my true signature. Also attached is a genuine copy of the Minor's school identification card, driver's license or other acceptable form of government-issued identification bearing the Minor's photograph, which may be used to verify the Minor's identity. I have personally reviewed the original and certify that it is genuine.
